On Mumbai-Nashik-Mumbai Highway Complete pending tasks promptly - Chief Minister Eknath Shinde

For filling potholes on highways Use of " Leo Polymer Technology". Will be useful

Thane : on the road For filling potholes " Leo Polymer Technology " is a technology Use of this technology to bridge the potholes on the Mumbai-Nashik highway as it is sustainable for a long time will be done. Where there are potholes or traffic jams , After inspecting all such places, Chief Minister EknathShinde gave instructions to the concerned authorities to fill these potholes immediately using " Leo Polymer Technology " . At the same time, Thane -Nashik Chief Minister EknathShinde directed that the pending road works on the highway should be completed immediately Officials have not given here today . Chief Minister EknathShinde today announced that Kharegaon to Padgha on the Thane-Nashik highway , Inspected the road from Talvali to Shahapur . The Chief Minister himself went down on the road and inspected the work being done in connection with filling the potholes on the road to see the causes of the traffic jam . He was talking to the media at that time. Thane Municipal Commissioner SaurabhRao, MMRDA Commissioner Sanjay Mukherjee, Collector Ashok Shingare , MSRDC Managing Director and Vice Chairman Mr. Anil Gaiikwad , Superintendent of Police Dr. D. Swamy , Deputy Commissioner of Transport Dr.Dr.Vinay Kumar Rathod , Superintendent of Highway Security Police. Mohan Dahikar , Deputy Commissioner of Police SV Shinde , Road Transport and Highways Chief Engineer and Regional Officer Anshumali Srivastava , MMRDA Chief Engineer SK Suravse , Superintendent Engineer Ramesh Kiste , Highways Authority of India



Project Director BS Salunke , Public Construction Department Superintendent Engineer SA Tamba , Executive Engineer Sunil Patil , along with other relevant officials were present.Speaking to the media on this occasion, Chief Minister Shri. Shinde said that the Thane-Nashik distance is currently taking more time than usual. This situation has arisen due to the stones on this road and the traffic of heavy vehicles here. After meeting the relevant departments of Public Works, Maharashtra State Road Development Authority, MMRDA, Police , heavy vehicles should be parked in the parking lot and traffic should be started . Heavy vehicles will be released when the traffic

slows down . A Sha A kind of planning has been done. Similarly, the three districts of Raigad , Thane and Palghar regarding the vehicles coming from JNPT. Collector , Commissioner of Police and Superintendent of Police They have been instructed to make necessary arrangements regarding these vehicles .He said, coordination has given instructions to ensure that WahTu Key will be regulated . No kind of construction material survives in the pits that fall during monsoon . Therefore To fill these potholes, SMC Infrastructure Pvt." Leo Polymer Technology " invented by the engineers of Ltd. has been used. It contains fiber. Heavy vehicles can also pass through it. The work of

filling large patches on this highway using this technology is going on at war level. The entire road between Thane-Nashik and Nashik-Thane will be filled with this technology. This method is sustainable. So people will not suffer from potholes while traveling.The Chief Minister thanked Suhas Mehta and his team of SMC Infrastructure Private Limited on this occasion. Instructing the concerned that criminal action should be taken against those obstructing this work, he further said that this is a matter of lakhs of passengers. Whose road is this , who is

making it , who is doing this work, it is not important, but everyone has to complete this work as a team. We want to help people to travel easily using new technology. We are going to use this method on all the bridges like Jindal, Washind, Asangaonrailway bridge. Potholes on Bhiwandi and Mankoli routes will also be filled. In the future, a bridge will be constructed at KhadvaliPhata, so the traffic congestion here will also be reduced. Instructions have been given to the concerned to complete these roads at the earliest with maximum utilization of manpower and mechanical materials.

Today we got the freedom to hoist the national flag because our forefathers sacrificed. I request the citizens that democracy has come to our country, everyone should come together for our

Today, under the leadership of Chief Minister EknathShinde , Deputy Chief Minister DevendraFadnavis , and Deputy Chief Minister AjitPawar, the development of Mumbai is going on very fast.The government is working according to the guidance given by Prime Minister Narendra Modi that priority should be given to doing works of public interest.
